
# BOARD OF DIRECTORS MEETING SUMMARY 406 Billington Street, Plymouth 6:00 PM • WEDNESDAY • 09-04-2012



Meeting called to order 6:11pm by R. Parker.

## Christmas Ornament:

- Discussion of cost (\$15.33 ea), profit, selling price, cash flow through Treasury, volunteer labor to get it all done.
- Volunteers who offered to help include Jeff, Tina, Will, Barbara and Galen (and Leslie).
- Motion by Randy: To order 150 "Charlie Brown" ornaments, to be sold at \$25.00 to include sales tax, shipping & handling. If purchased with a 2011 ornament, total selling price to be \$40.00. First by Randy and second by Jeff. Motion passed 7-1 with Mary Ellen in the negative.

## • Treasurer's Report given verbally:

- o \$7,718.56 in checkbook with \$370 monthly insurance payment commitment.
- Brought up matter that books must be reviewed "as proper" by a CPA for 1<sup>st</sup> time after first full year, going into second year. Estimate of \$2,500-3,000 for CPA review is "about right".
- Also, 2010 tax return/990 form was given extension in Dec-2010 until Nov-2011, then given a new extension with new due date of November 2012 (for 2010 Return). Cost of reviewing tax return is not known. What about 2011 tax return and when is it do?
- o Treasurer recommending that we order up audit immediately.
- Tax "forms" for selling Simes House items including ornaments and Simes wear can't be filed until the tax return is filed.
- Motion by Randy: Recommendation given to approve that CPA (Heather Cozby) to complete tax return, audit books and coordinate state tax forms for selling items. Second by Jeff. Motion passed 7-0 with one abstention by Jim H.

#### GO Team:

- Barbara suggested need to organize a work party to clear the north side of the property in preparation for general contractor working on restoration.
- Galen to coordinate detail.

### Tree Lighting:

- Much footwork needed to plan all activities for possible tree lighting of "Charlie Brown" this year on Simes House property.
- Need a committee to run event, coordinate lighting installation, refreshments, entertainment.
- O Use as a fund-raiser for ornaments and Simeswear.
- Marketing to include news releases, "house under construction", focus on Stop n'Shop in Manomet, and selling Simes goods.
- o Must approach Knights of Columbus (Mary Ellen) and Town of Plymouth (Randy).
